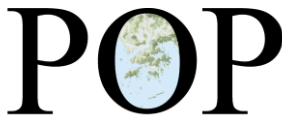

### **HKPOP “We Hongkongers Survey” Online Forum Participation Guidelines**

1. Join the Zoom meeting 15 minutes before the forum starts (i.e. by 2:15pm) using this link: <https://zoom.us/j/92925996764?pwd=aE5VakF5TjcyMzdJSTFDZ01ReGlaUT09>

Passcode: 199935; or by scanning the QR Code on the right
2. Before entering the Zoom meeting room, please rename your account showing your name and representing organisation;
3. Wait for the host for admitting you in the Zoom meeting room;
4. Before the Q&A session, submit your question with your name and representing organisation to the host at CHAT room in Zoom; in case of technical problem, your question may be read out by the meeting host;
5. During the Q&A session, the host will give you signal when it will soon be your turn to ask question;
6. Upon receiving signal from the host, unmute your mic to ask question; in case technical problems creep in, the host would read out your question;
7. No foul language or personal attacks is allowed; the host will cut off the conversation when this happens;
8. In case of time constraint, some questions may not be entertained.
