- Please join the Zoom meeting at least 10 minutes before the press conference starts (i.e. by 2:20pm for meetings to start at 2:30pm) by using the following weblink: https://zoom.us/j/92925996764?pwd=aE5VakF5TjcyMzdJSTFDZ01ReGlaUT09
 - Meeting ID: 929 2599 6764; Passcode: 199935; or by scanning the QR Code on the right.
- 2. Please name or rename your account showing your name and your organisation; people with unclear or sceptical identification may be refused admission.
- 3. Wait for the host to admit you into the **Zoom Meeting Room**.
- 4. During the Q&A session, when you want to raise a question, please submit it in writing to the host at the Zoom Chat Room; this is a backup measure so that in case of technical problem, your question may be read out by the moderator.
- 5. The host will then give you signal when it is almost your turn to ask your question.
- 6. Please then <u>unmute your Zoom</u> session microphone to ask your question; in case technical problems creep in, the moderator will read the question for you.
