

Please name or rename your account showing your name and your organisation; people with unclear or sceptical identification may be refused admission.



- 4. During the Q&A session, when you want to raise a question, please submit it in writing to the host at the Zoom Chat Room; this is a backup measure so that in case of technical problem, your question may be read out by the moderator.
