香港民研發放特首及政府民望

特別宣佈

香港民意研究所(香港民研)早前與康乃爾大學(Cornell University)羅珀民意研究中心(Roper Center for Public Opinion Research)達成數據分享協議,民研在未來的日子會逐步向羅珀民研中心提供歷年定期調查的原始數據,並上載至其 iPoll 平台,供世界各地的學者、傳媒及公眾人士使用。首個共享的原始數據集已於 11 月 15 日發佈,為香港民研於 2019 年 7 月進行的定期電話調查,內容包括特首和主要官員民望、立法會議員民望、台灣及西藏問題等 8 個長期追蹤調查系列,合共 35 條題目。歡迎有興趣人士到 iPoll 平台 https://ropercenter.cornell.edu/ipoll/ 瀏覽及下載。香港民研將繼續與羅珀民意研究中心合作,令香港的民意數據得以有系統地保存,並與全世界分享。

公報簡要

香港民研於十一月由真實訪問員以隨機抽樣電話訪問方式成功訪問了1,004名香港居民。

調查顯示,特首李家超的最新評分為 52.7 分,與一個月前變化不大,有 13%受訪者給予 0 分。 與此同時,其民望淨值為正 30 個百分點,創其上任以來新高。政府民望方面,特區政府的滿 意率淨值為 0 個百分點,數字相比一個月前沒有顯著變化。

調查的實效回應比率為 51.4%。在 95%置信水平下,調查的百分比誤差不超過+/-4%,淨值誤差不超過+/-8%,評分誤差不超過+/-2.0。

加權方法 : 按照政府統計處提供的統計數字以「反覆多重加權法」作出調整。全港人口

年齡及性別分佈統計數字來自《二零二二年年中人口數字》,而教育程度(最高就讀程度)及經濟活動身分統計數字則來自《香港的女性及男性 - 主要統

計數字》(2022年版)。

- [1] 數字為調查的總樣本數目,個別題目則可能只涉及次樣本。有關數字請參閱下列數表內列出的樣本數目。
- [2] 此公報中所有誤差數字均以 95%置信水平計算。95%置信水平,是指倘若以不同隨機樣本重複進行有關調查 100 次,則 95 次各自計算出的誤差範圍會包含人口真實數字。由於調查數字涉及抽樣誤差,傳媒引用百分比 數字時,應避免使用小數點,在引用評分數字時,則可以使用一個小數點。

- [3] 2023年7月開始,特首假設投票問題的字眼已經由「假設明天選舉特首,而你又有權投票,你會唔會選李家超做特首?」更新為「假設你而家有權決定續任或者罷免李家超作為特首,你會點樣決定?」以呼應香港現在的發展。答案選項亦已由「會」和「唔會」改變為「續任」、「罷免」和「棄權」,而「唔知/難講」和「拒答」選項則繼續採用。

政府民望方面,特區政府的最新滿意率為 42%,不滿率為 43%,滿意率淨值為 0 個百分點。 而平均量值為 2.9 分,即整體上接近「一半半」,數字相比一個月前沒有顯著變化。

HKPORI releases popularities of CE and SAR Government

Special Announcement

The Hong Kong Public Opinion Research Institute (HKPORI) has earlier reached a data sharing agreement with the Roper Center for Public Opinion Research of Cornell University, whereby HKPORI will gradually provide Roper Center with the raw datasets of its regular surveys over the years, and upload them onto its iPoll platform for use by scholars, media and general public worldwide. The first raw dataset shared has been released on November 15, which is the regular telephone survey conducted by HKPORI in July 2019, covering 8 tracking poll topics, such as the popularities of CE and Principal Officials, Legislative Councillors, Taiwan and Tibet issues, with a total of 35 questions. Interested parties are welcome to browse and download them from the iPoll platform at https://ropercenter.cornell.edu/ipoll/. Going forward, HKPORI will continue to cooperate closely with Roper Center, so that public opinion data in Hong Kong can be systematically preserved and shared with the rest of the world.

Abstract

HKPORI successfully interviewed 1,004 Hong Kong residents by a random telephone survey conducted by real interviewers in November.

Our survey shows that the latest popularity rating of CE John Lee stands at 52.7 marks, which did not change much over the month past. Among all respondents, 13% gave him 0 mark. His net popularity stands at positive 30 percentage points, which is an all-time record high since he took office. As for the SAR Government, its net satisfaction is 0 percentage point, which has not changed much compared to a month ago.

The effective response rate of the survey is 51.4%. The maximum sampling error of percentages is \pm 4%, that of net values is \pm 8% and that of ratings is \pm 2.0 at 95% confidence level.

^[3] Starting from July 2023, the question on hypothetical voting on CE has been revised from "If a general election of the Chief Executive were to be held tomorrow, and you had the right to vote, would you vote for John Lee?" to "If you had the right to decide whether to reappoint or dismiss John Lee as the Chief Executive now, how would you decide?" to echo the development in Hong Kong now. Answer options have also been changed from "yes" and "no" to "reappoint", "dismiss" and "abstain", while "don't know / hard to say" and "refuse to answer" options continue to exist.

Our survey shows that the latest popularity rating of CE John Lee stands at 52.7 marks, which did not change much over the month past. Among all respondents, 13% gave him 0 mark. The latest approval rate of CE is 57%, disapproval rate 27%, giving a net popularity of positive 30 percentage points, which is an all-time record high since he took office.

^[2] All error figures in this release are calculated at 95% confidence level. "95% confidence level" means that if we were to repeat a certain survey 100 times with different random samples, we would expect 95 times having the population parameter within the respective error margins calculated. Because of sampling errors, when quoting percentages, journalists should refrain from reporting decimal places, whereas one decimal place can be used when quoting rating figures.

^[4] The difference between the figure and the result from the previous survey has gone beyond the sampling error at 95% confidence level, meaning that the change is statistically significant prima facie. However, whether the difference is statistically significant is not the same as whether they are practically useful or meaningful, and different weighting methods could have been applied in different surveys.

- [5] Collapsed from a 5-point scale. The mean value is calculated by quantifying all individual responses into 1, 2, 3, 4, 5 marks according to their degree of positive level, where 1 is the lowest and 5 the highest, and then calculate the sample mean.
- [6] The difference between the figure and the result from the previous survey has gone beyond the sampling error at 95% confidence level, meaning that the change is statistically significant prima facie. However, whether the difference is statistically significant is not the same as whether they are practically useful or meaningful, and different weighting methods could have been applied in different surveys.

As for the SAR Government, its latest satisfaction rate is 42%, whereas dissatisfaction rate stands at 43%, thus the net satisfaction is 0 percentage point. The mean score is 2.9, meaning close to "half-half" in general. These figures have not changed much compared to a month ago.
